1:15 – 2:15 – Gag Clause, Agency, Congressional and Litigation Roundup — What impact does the Gag Clause have on TPAs and their agreements with plan sponsors? Should TPAs make the attestation on behalf of its plan sponsor clients? Proposed regulations were recently issued addressing fixed indemnity and MEC arrangements. The agencies issued FAQ 60 addressing the application of the OOP maximum rules under the ACA and OON services under the No Surprises Act. The courts are active with cases affecting the self-funded industry. Cases regarding claims overpayments and excess fees seem to have risen to the top of the dockets — requiring special attention to our claims processing practices and fee arrangements.
