This paradigm ignores the unique characteristics of each individual, resulting in one-size-fits-all care that often overlooks the needs of members who are newly rising in risk, and likely to become high utilizers in the future. This session will discuss the role of machine learning in driving proactive, personalized engagement based on a deep understanding of each member's characteristics. The result is earlier identification of which patients in a population are likely to be emerging risk or rising risk, and what their specific risks are. This informs targeted and individualized outreach to get in front of adverse health events, rather than trying to claw back irreversible health deterioration after the fact.
